The undersigned affiant, DAVID A. CURRY, being first duly sworn, hereby deposes and says:

- 1. I am over the age of eighteen, suffer no legal disabilities, and have personal knowledge of the facts set forth below.
- 2. I reside at 53 Greenridge Way, Spring Valley, Town of Ramapo, New York, 10977 and have done so since August, 1997.
- 3. I am registered to vote with the Rockland County Board of Elections and have been so registered since 1997.
- My polling place is the Firemen's Training Center, 36 Firemen's Memorial Drive,
 Pomona, New York 10970.
- 5. On Tuesday, September 30, 2014 at approximately 6:45pm I went to the Firemen's Training Center to vote in the Town of Ramapo referendum on adopting a ward system for the election of town board members and on increasing the number of board members from four to six.
- 6. While I was waiting in line to check in and receive my ballot, I asked one of the poll workers about affidavit ballots for unregistered voters, as my oldest son, who needed one, had told me he was unable to vote earlier in the day (see "Affidavit of Trevor A. Curry").

- 7. The poll worker indicated "we have affidavits" but professed no personal knowledge of whether or not unregistered individuals were allowed to vote. He directed me to speak to the woman in charge of the polling place, at a table near the front door.
- 8. After casting my ballot, I went to the table near the front door to ask the woman in charge about affidavit ballots. A couple in front of me were asking the same question, and she informed them, within my hearing, that she had no affidavit ballots left, but had been told that 40 more affidavits were on the way. She advised the couple to come back "much later" in the evening to vote and stated that there was no way for them to vote at the present time.
- 9. After the conversation had concluded, I mentioned to the couple that my son had been there two hours earlier and been told much the same thing. Coincidentally, the couple who live across the street from me were also there, and joined our conversation.
- 10. My neighbors mentioned that they had not known where to vote, and had initially went to the polling place at Spring Hill Ambulance Corps on Brick Church Road (which is much closer to where we live). They told the couple and me that "Spring Hill has lots of affidavits."
- 11. At approximately 7:00pm, my son sent me a text message stating that he had returned to the Firemen's Training Center and that they still had no affidavits, and asked what he should do.
- 12. Based on the information my neighbors had provided me, I suggested to my son that he go to Spring Hill Ambulance Corps to see if they had affidavits and whether they would let him cast his vote.

13. Upon returning home at approximately 7:30pm, my son told me that he had gone to Spring Hill Ambulance Corps, that they did indeed have plenty of affidavits, and that they allowed him to cast his vote.
