

AFFIDAVIT OF TREVOR A. CURRY

The undersigned affiant, TREVOR A. CURRY, being first duly sworn, hereby deposes and says:

1. I am over the age of eighteen, suffer no legal disabilities, and have personal knowledge of the facts set forth below.
2. I reside at 53 Greenridge Way, Spring Valley, Town of Ramapo, New York, 10977 and have done so since August, 1997, with the exception of the time from August 2008 through June 2014 when I resided in Cortland, New York.
3. Prior to 2008 I was registered to vote with the Rockland County Board of Elections. I am currently registered to vote with the Cortland County Board of Elections. I have not yet moved my registration back to Rockland County.
4. The polling place for my address of residence is the Firemen's Training Center, 36 Firemen's Memorial Drive, Pomona, New York 10970.
5. On Tuesday, September 30, 2014 my father informed me that even though I was not currently registered to vote in Rockland County, I was, as a town resident, still eligible to vote by affidavit in the Town of Ramapo referendum on adopting a ward system for the election of town board members and on increasing the number of board members from four to six.

6. On Tuesday, September 30, 2014 at approximately 4:30pm I went to the Firemen's Training Center to cast my vote.
7. When I asked a poll worker about affidavit ballots, I was directed to speak to the woman in charge of the polling place, at a table near the front door.
8. When I spoke to the woman in charge, she informed me that she had no affidavit ballots left, but that more were on the way. She advised me to "come back later" in the evening to vote and stated that there was no way for me to vote at the present time.
9. After returning home, I sent my father a text message to tell him of the problem, and said that I would try to go back to the polling place later.
10. At approximately 7:00pm, I returned to the Firemen's Training Center as instructed, and was told by the woman in charge that she still had no affidavit ballots, but that they were coming and would "be here momentarily." She mentioned that she had only had ten ballots at the start of the day.
11. While I was waiting for the ballots to arrive, I sent my father a text message that there were still no affidavit ballots.
12. My father replied that he had heard that the polling place at Spring Hill Ambulance Corps on Brick Church Road had affidavits (see "Affidavit of David A. Curry"), and suggested that I go there and see if they would let me cast my vote. I decided to do that.
13. Upon arriving at Spring Hill Ambulance Corps at approximately 7:15pm, I discovered that they did indeed have plenty of affidavits, and they allowed me to cast my vote.
