I make this affidavit in connection with the pending action in New York State Supreme Court commenced by Michael Paretti and Robert Romanowski relating to allegations of certain improper activities during the course of the ward referendum vote held on Tuesday, September 30, 2014 in the Town of Ramapo.

The following is a summary of my personal experience regarding the referendum vote as follows, which I ask the court to take into consideration in rendering any decisions in this legal action:

I, MARY WILKES, MACHINE CUSTODIAN, ROCKLAND COUNTY BOARD OF ELECTIONS QUALIFIED UNDER OATH TO SERVE AS INSPECTOR OF ELECTIONS, 2014. POLL SITE (SPECIAL ELECTION) MONTEBELLO COMMUNITY CENTER. INSTRUCTIONAL MEETING, SEPTEMBER 23, AT RAMAPO TOWN HALL. CHRISTIAN SAMSON, TOWN OF RAMAPO TOWN CLERK CONDUCTED THE MEETING. ELECTION INSPECTORS WERE NOT INFORMED ON SEPTEMBER 23 THAT THE SPECIAL ELECTION WOULD PERMIT NON-REGISTERED VOTERS AND NON-CITIZENS TO VOTE OR HOW TO DEAL WITH AFFIDAVIT BALLOTS. ELECTION INSPECTORS WERE CONCERNED THAT MANY UNREGISTERED VOTERS DEMANDED BALLOTS. ELECTION INSPECTORS REPORTED THE SITUATION TO MR. SAMSON (A.M.) MR. SAMSON ARRIVED AT POLL SITE (A.M.) AND ANNOUNCED THAT: "UNREGISTERED VOTERS WOULD BE PERMITTED TO VOTE AND WE WERE NOT TO FOLLOW THE ROCKLAND COUNTY ELECTION LAW," (TAKEN UNDER OATH), "BUT THAT THIS SPECIAL ELECTION WOULD FOLLOW THE TOWN OF RAMAPO MUNICIPAL LAW." INSPECTORS REPORTED THE STATEMENT TO THE NEW YORK STATE ATTORNEY GENERAL'S OFFICE AND THE ROCKLAND COUNTY EXECUTIVE. I REPORTED THE SITUATION TO ASSEMBLYMAN KENNETH ZEBROWSKI.

I understand that the court will be relying on the accuracy of this affidavit in any judgments and decisions made in connection with the above legal action.
